Relationship Agreements

Entering into marriage or a civil partnership is a life-changing step and requires careful consideration.

It is prudent to consider the possible consequences of a breakdown in the relationship in advance to provide certainty.

A prenuptial agreement can set out in advance how assets are to be divided. It gives each person the opportunity to consider what would be fair and reasonable in the event of a split.

This can be particularly important where one party is bringing significant assets into the marriage, where one person had inherited assets they wish to protect, or in second marriages.

Postnuptial agreements are also available if you are already married and wish to regulate the financial situation between you and your proposed spouse.

It is important that you take advice well in advance of your intended wedding date.

Cohabitation and Unmarried Families

There is no such thing as a 'common law' marriage. Unmarried couples do not have the same rights as married couples.

A cohabitation agreement can be used to formalise the financial arrangements between an unmarried couple, so that both individuals know what their respective contributions will be. It can also set out the rights of each individual to avoid a dispute or uncertainty if the relationship fails.

The law relating to cohabitation is provided by the Trustees of Land Act which is extremely complicated and requires legal input at an early stage.

Separation, Divorce or Dissolution of Civil Partnership

The breakdown of a relationship is a difficult and emotional time. There is uncertainty about the future and what needs to be done. We offer sensitive and bespoke advice to individuals from all walks of life.

The process can be straightforward but there are complicating factors, and you should not divorce before considering the implications on your family financial situation.

We will guide you through the process of separation and/or divorce, and explain the options available to you.
